I now all men by these presents that I Dennis Wheelock  
 of Mendon in the County of Worcester and Common-  
 wealth of Massachusetts yeoman together with Lucinda  
 my wife in token of the relinquishment of her right of  
 dower in consideration of the sum of fifty dollars paid  
 to me by Nathaniel Inman of the town County and  
 Commonwealth aforesaid yeoman the receipt whereof  
 I do hereby acknowledge do hereby give grant sell  
 and convey unto the said Nathaniel Inman his heirs  
 and assigns forever a certain piece of pasture and  
 meadow land butted and bounded as follows  
 to wit) Beginning at a Southwesterly corner of the  
 grantors pasture adjoining the grantors meadow thence  
 Southerly about twenty six rods to the grantors barn  
 lot thence Easterly about twenty six rods to a corner of  
 the grantees pasture the two last mentioned lines  
 bounding Westerly and Southerly on the grantors other  
 land then Northerly, Westerly, Northerly, and Westerly to the  
 place of beginning the four last mentioned lines  
 bounding Easterly, Northerly and Easterly and Northerly  
 on the granted land containing by estimation three  
 acres be the same more or less To have and  
 to hold the same to the said Nathaniel Inman his  
 heirs and assigns to his and their use and behoof forever  
 And I do covenant with the said Nathaniel Inman  
 his heirs and assigns that I am lawfully seized in fee  
 of the premises that they are free of all incumbrances  
 that I will warrant and defend the same to the  
 said Nathaniel Inman his heirs and assigns  
 forever against the lawful claims and demands of all  
 persons - In witness whereof I the said Dennis  
 Wheelock together with Lucinda my wife have hereunto  
 set our hands and seals this sixth day of September  
 in the year of our Lord one thousand eight hundred  
 and thirty three - Dennis Wheelock seal
