And the said Joseph Adams, for myself, my Heirs, Executors and Administrators, do covenant with the said Lebbeus Gaskill his Heirs & Assigns, that I am lawfully seized in fee of the premises, that they are free of all Incumbrances, that I have good Right to sell and convey the same to the said Lebbeus Gaskill to hold as aforesaid & that I will warrant and defend the same to the said Lebbeus Gaskill his Heirs & Assigns forever, against the lawful claims & demands of all persons. — In witness whereof, I the said Joseph Adams and Sarah wife of the said Joseph who doth hereby release all her right of dower in the above described premises have hereunto set our hands and seals this fourteenth day of March in the year of our Lord one thousand eight hundred & twenty seven.
